## Portrait of an Era

A Social History of Medicine in Singapore from 40 Years of SMJ

In the last four decades, the SMJ has charted medical progress and reflected the socio-economic transformation in Singapore. The published papers of local research defined these changes and have become milestones that acquired a 'sepia tone' with the march of time. The first issue of the SMJ was dated March 1960 with Dr Gwee Ah Leng as the first editor, and the contents of the Journal in the sixties mirrored the insalubrious state of public health; they were predominantly on malnutrition and infections, eg. tetanus, gonorrhoea, leprosy, cholera, syphilis, tuberculosis, malaria, etc.



In the early 1970s, reports on associated social problems included opium smoking (SMJ June 1970) and alcoholism (SMJ June 1971). The rapid industrial development in the island prompted a study on environmental health in the factory (SMJ September 1977), and other major social changes reported were national service (SMJ Vol 18, 1977), family planning and the Abortion Act (SMJ October 1971). By the end of the decade, the drug scene had changed and heroin (SMJ Vol 19, 1978) and smoking (SMJ Vol 20, 1979) became national issues. The growing interest in golf was indicated in a case report of eye injury due to the sports (SMJ March 1975) and the advent of the video technology suggested that it could be used as a valuable teaching aid (SMJ Vol 20, 1979).

Interestingly, in the 1980s, the published work on disease patterns was decidedly different. AIDS or Acquired Immunodeficiency Syndrome in Singapore was highlighted and stress related disorders, namely anorexia nervosa (SMJ Vol 23, 1982) and work stress (SMJ Vol 30, 1989) were reported. The tragedy at the Hotel New World with doctors in the rescue team was documented (SMJ Vol 29, 1988).

In the 1990s, communicable diseases no longer dominated the contents of the Journal, but the spectre of escalating health cost prompted reviews on consultation fees (SMJ Vol 34, 1991), information technology in healthcare cost containment (SMJ Vol 36, 1995), medical audit (SMJ Vol 32, 1991) and case mix (SMJ January 1999). Significant health matters featured in the Journal were the ageing population, hepatitis vaccination, cancer, obesity, advance directive, mental health and doctor's stress. The Mass Rapid Transit (MRT) is a landmark in national development and a study on 'Decompression sickness in the MRT Project' was published (SMJ Vol 31, 1990). A paper on the international traveller

The published papers of local research defined these changes and have become milestones that acquired a 'sepia tone' with the march of time.

For more than four decades, doctors have volunteered their services to many charitable organisations like children's homes, old people's homes, drug rehabilitation centres, day care centres, etc. An editorial on 'voluntarism' (SMJ Vol 31, 1997) acknowledged the selfless dedication of these doctors.

In research and medical technology, activities were sluggish in the sixties and seventies but burgeoned in the last two decades. Notable publications in the sixties included choriocarcinoma (SMJ September 1965); new techniques in obstetric care, eg. vacuum extractor (SMJ December 1966) and amniotomy (SMJ March 1969); corneal grafting (SMJ June 1967) and mammography (SMJ December 1968). In the 1980s, the Journal published the research on genetic association in infertility (SMJ Vol 22, 1981), rice gruel for infantile diarrhoea (SMJ August 1985) and colorectal cancer (SMJ February 1985); technological advances reported were artificial insemination (SMJ August 1982) and lithotripsy (SMJ Vol 30, 1989).

Medical technology accelerated at a ferocious pace in the 1990s and there were publications on stereotactic neurosurgery, intracoronary stent, computer enhanced health care delivery, transurethral microwave thermotherapy, Hologic QD2000 for bone mineral density measurement and minimally invasive direct coronary artery bypass. The local doctors also reported their experience in liver transplant, cancer treatment and acupuncture.

New thoughts on medical education were emphasised in two papers on 'Rethinking Medical Education' (SMJ Vol 39, 1995) and 'What Makes a Good Doctor' (SMJ Vol 39, 1998). They underscored the need to re-examine the training of our future doctors and contributed to the debate on a modern curriculum for medical students.

More openess in the political system could have encouraged candour in the evaluation of medical services and there were studies on auditing coronary angioplasty (SMJ Vol 38, 1997) and patients' complaints (SMJ Vol 38, 1997 and Vol 39,1998). Unfortunately the results of complaints in the Emergency Department was highlighted negatively in the local press, which had misunderstood the essence of the research. It is undeniable that evaluation and audit are essential for progress in any research centre.

Traditionally, the theme of the annual SMA Lecture underscores topical medical matters, both current and controversial, reflecting the zeitgeist. In 1963, Dr Gwee Ah Leng gave a scholarly lecture with prophetic overtones on advertisement (SMJ March 1963) and in 1971, Dr Yahya Cohen eloquently exhorted, "... values such as pride but not arrogance; of discipline but not servility; of respect but not fear; of loyalty but not subservience." (SMJ Vol 12,1971). Professor S S Ratnam echoed the doctor's dilemma in the 1977 SMA lecture and suggested, "... more opportunities should also be developed for friendly and open dialogues between government and

and requirements and work together in bettering professional 18,1977).

In his inimitable style and appealing to our superego, Professor Arthur Lim in the 1981 SMA Lecture cautioned, "We must revolutionise our way of thinking: monetary gains should assume secondary importance. Professional status must be earned through hard work and not ruthlessly attained." (SMJ August 1981). For the future of Singapore Medicine, Dr Charles Toh in the 1997 Lecture counselled, ".... we must be firmly committed to the philosophy that service to the patient, medical education and research are inseparable if we are to continue to excel as a regional hub." (SMJ Vol 38, 1977).

The SMJ has in the last 40 years chronicled the social history of public health and medical advances in Singapore. As you scan through the catalogue of papers culled from the archives, it is amazing that some of the diseases in the 1960s are now rarely encountered. In reminiscence there is always a sense of nostalgia when you personally know some of the doctors who published the early research, albeit encumbered by heavy clinical duties and provided with impecunious resources.

Among doctors, parsimony with compliments is the rule and compliments are usually rationed; it was with delight that the Editorial Board received a note from Professor Arthur Lim, written with economy of words, "Congratulations, the SMJ has improved." Thanks, Art.



# SMA Lecture IMPACT OF A FREE MARKET SYSTEM ON MEDICINE IN SINGAPORE

C Toh. SMJ Vol 38, 1997

- (1) That economic growth driven by a free market does not necessarily translate into better health care for all.
- (2) Government needs to have in place a comprehensive and regulated system of health care financing so that all sectors of community will be taken care of.
- (3) A free market system tends to encourage the growth of social insurance and managed care but evidences show that they cannot address the issue of providing cost worthy health care at a national level. The less affluent and aged will suffer under this system, and medical practice will be controlled by business organisations.
- (4) Restructuring of our public hospitals has enabled them to exercise greater initiative to upgrade and to be more effficient. It is here to stay, but requires fine tuning constantly.
- (5) The free market system operating within our health services is not conducive to medical research. Hence, new means of funding research are being introduced to enhance a better balance of clinical service, teaching and research.
- (6) If our economic growth does not falter, our present model of health provision and financing should continue to serve us well.

### SMJ in the New Era and the Ethics of a Journal

The focus and contents of the SMJ have evolved gradually in the last 40 years. A new format of the Journal has also evolved through self-transformation and renewal to give it a new identity and persona. The readership has expanded and the SMJ has now taken a regional stance. There has been an enormous increase in the number of scientific papers from the Asean countries, and also from Australia, the United States and the United Kingdom. The Malay abstracts were published in June 1998 for doctors in Indonesia and Malaysia.

Any scientific journal which discusses the responsibilities of authors but ignores the ethics of refereeing loses faith and credibility. The refereeing process must guard against prejudice and the SMJ should not ignore papers from countries where English is not the forte of the authors. Having an international vision means there is no cerebral space for parochialism and we should repudiate any pettifogging in refereeing. The market place for ideas should not merely be sacrosanct to the research institutes and reject the rich experience of clinicians working in less privileged hospitals. The SMJ will continue to publish high calibre scientific papers subjected to peer review because it has a commitment to education and information for all the readers and contributors in the region.

As the years unfold, the SMJ will attain a venerable age and will continue to grow with a sense of verve and cachet.
