Scoping review on medical and social domains of ageing research in Singapore (2008–2018)

ABSTRACT

Introduction: To examine how ageing research in medical and social domains in Singapore

has transformed over time, this scoping review examined the number, types and characteristics

of journal publications on ageing in Singapore from 2008 to 2018.

Methods: Using relevant search terms, articles were extracted from multiple databases and

then screened and reviewed for eligibility and inclusion by independent reviewers. Data such

as title of the study, authors, year of publication, name of journal, type of journal, study design

and the kind of data used were charted from the included articles for evidence synthesis.

Results: Since 2008, there has been a steady increase in the number of publications on ageing

in medical and social domains in Singapore. In the medical domain, publications in

Ophthalmology formed the largest group of the existing medical literature on ageing in

Singapore (22%), followed by Physical Functioning, which involved physiological

measurements of physical well-being (17%) and Geriatrics (16%). Non-medical publications

comprised 38% of all the included publications, with publications on the social aspects of

ageing forming the largest group in this cluster (43%), followed by publications on Prevention

(19%) and Healthcare Services (18%). Most studies were observational in study design (82%),

with only 3% of interventional studies.

Conclusion: While ageing research had expanded in Singapore in the last decade, it was

predominantly discipline-specific and observational in design. As ageing issues are complex,

with biology intersecting with psychology and sociology, we call for greater interdisciplinary

collaboration, interventional studies and more research in understudied and emerging areas.

INTRODUCTION

By 2030, it is estimated that one in four of Singapore's population will be above 65 years old.⁽¹⁾ Singapore's demographic transition will present many medical and social challenges. Hence, it is important to examine how ageing research in these domains in Singapore has changed over time. By mapping the kind of research that has been published and examining their characteristics, we can gain insights into the current state of research and recommend directions for future research.

Reviews on ageing research in Singapore tended to take the form of an exposition of the demographic transition that had occurred and the policy challenges that had resulted from it.⁽²⁻⁴⁾ The general concern was how to contain these challenges so that ageing did not present as a societal burden.⁽⁵⁾ Many of these reviews are policy-centric and rely on expert assessment of the ageing situation. There seems to be a lack of a systematic empirical enumeration of the number and type of published studies in the main domains of ageing research, including medical and social ones, which could better inform trends in the literature.

This scoping review aims to find out: (1) the frequency of what has been published in the medical and social domains of ageing in journals; (2) the characteristics of these studies such as their research design and use of data; (3) the trends of these publications over the last decade; and (4) the gaps in these publications. We hope that through such a systematic mapping of publications over the past decade, there will be a stronger empirical basis to discern trends in ageing research. To our knowledge, there has been no such scoping review on ageing research conducted in Singapore previously.

METHODS

Search criteria

As can be seen from Fig. 1, the search criteria were kept as open as possible to capture the full spectrum of literature that exists, subject to the following criteria. Inclusion criteria: (1) journal articles related to the medical and social domains of ageing in Singapore; (2) published from January 2008 to December 2018; (3) empirical research; (4) written in English; (5) studies conducted with the local general population or cohorts. Exclusion criteria: (1) commentaries, editorials, reviews, study protocols, book chapters, dissertations, conference papers; (2) studies that validated scales; (3) not relevant to ageing; and (4) not conducted in Singapore.

Search strategy

In Fig. 1, to capture relevant publications, a search of major databases was performed on 7 March 2018 for publications from 2010 to March 2018. The search was subsequently expanded on 28 February 2019 for publications from 2008 to 2009 and from March to December 2018 to reflect decade-long changes to the characteristics and trends of journal publications on ageing in Singapore. The results of the search strategy are reported in Fig. 2, as per the Preferred Reporting Items for Systematic Reviews and Meta-Analyses (PRISMA) statement and guidance on the conduct of narrative synthesis in scoping reviews. (6) The PRISMA-ScR checklist is presented in the Appendix.

Study selection

In Fig. 2, a total of 12,908 publications were identified. After the removal of duplicates, the remaining records were screened against the inclusion and exclusion criteria and their abstracts were screened independently by four reviewers (EH, TCH, SH and ST). The full-text articles were then retrieved and independently assessed for eligibility by the same reviewers. All

disagreements were resolved through discussion among all the reviewers until a consensus was reached. The screening process yielded 684 eligible publications. These publications were then classified by the general discipline they are in, as shown in Table I.

Specific data extraction form was developed after some eligible articles were pilottested by reviewers (EH, AG & EKX) for evidence synthesis. These data included the title of the study, authors, year of publication, name of the journal, type of journal, study design (whether the study was cross-sectional, longitudinal, observational, interventional, qualitative or mixed methods) and type of data used (quantitative, qualitative or both).

In view of the large number and heterogeneity of publications, we decided to analyse our results both (1) generally across all the eligible articles and (2) in greater depth only for those disciplines that have more than 15 articles in them. From Table I, the 12 disciplines which had 15 or more articles were further stratified by the subtopics within those disciplines. This yielded 589 articles in total for deeper analysis as shown in Table II.

RESULTS

General observations across all disciplines

Since 2008, there has been a steady increase in the number of publications on ageing in Singapore. As illustrated in Fig. 3, publications doubled from 45 in 2008 to 91 in 2018 during the 11-year period.

We classified the 684 publications into two groups, medical and non-medical. The medical group comprised 425 publications covering the medical disciplines such as Ophthalmology, Geriatrics, Psychiatry and a discipline which we described as Physical Functioning where its subtopics involved physiological measurements and functioning. The non-medical group had 259 publications and included the following disciplines: Social, Prevention, Healthcare Services, Built Environment, Policy and Planning, Healthy Ageing and

Technology as listed in Table I. As the bulk of these non-medical papers were essentially social and behavioural (43% Social), Prevention (19%) and Healthcare Services (18%), we decided to call it Social.

The majority (62%) of the included publications were on medical conditions in older persons. Publications in Ophthalmology formed the largest group of the existing medical literature on ageing in Singapore (22%). This finding is a testament to the well-established research in Ophthalmology in Singapore. As early as 2004, the Singapore Malay Eye Study (SiMES) was started. Between 2004 and 2015, the Singapore Indian Eye Study (SINDI) and the Singapore Chinese Eye Study (SCES) were undertaken.

Apart from the clinical papers, one major domain of research on ageing was on Physical Functioning which constituted 17% of the included medical publications. Another large group of publications within the medical literature was in Geriatrics (16%). Cognitive function was the main focus of these publications. Interestingly, the subtopic of frailty had received more research attention in recent years with publications increasing from one in 2011 to 4 in 2017. Other clinical specialities addressing medical conditions common in older patients included Psychiatry (11% of included medical publications), Cardiology (7%), Oncology (4%), and Endocrinology (4%).

Non-medical publications comprised 38% of the included publications. Publications on the social aspects of ageing formed the largest group and accounted for 43% of all the non-medical publications. The main subtopics of this cluster were, in order of decreasing frequency, caregiving (36% of all the Social publications), employment (11%), end-of-life issues (11%), social participation, support and networks (10%) and living arrangements (9%).

Publications on Prevention, which included subtopics such as nutrition, medication use, vaccinations and health behaviour, constituted the second largest group in the non-medical

cluster of literature (19%) while Healthcare Services formed the third largest group (18%). The subtopics here included home hospice service and long-term care services.

This was followed by publications on Built Environment (7%) and Policy and Planning (7%). The latter dealt with wider policies and longer-term planning of ageing issues. Research in Built Environment investigated how the attributes of the built environment promoted the physical and cognitive well-being of the elderly. Interestingly, the number of publications had increased for Built Environment from one in 2008 to 4 in 2017.

Study design

We categorised the publications into observational, interventional, qualitative, cost-effectiveness and mixed methods studies. Observational studies accounted for 82% of all the publications (n = 556). Only 22 of the 684 publications (3%) were interventional studies. Qualitative, cost-effectiveness studies and mixed methods accounted for 15% of all the publications. Of the 22 interventional studies, 86% of them (n = 19) were controlled and randomised. Three studies (14%) were uncontrolled and non-randomised.

Use of Data from Population-Based Studies

In this review, data from the Singapore Longitudinal Ageing Studies (SLAS) had been used in the largest (n = 64) number of publications. Data from SiMES were used in 50 publications in the review while those from the Singapore Chinese Health Study (SCHS) and the Well-being of the Singapore Elderly Study (WiSE) yielded 47 and 29 publications respectively.

Authors' affiliations

We divided each paper equally among its authors and those authors who had more than one affiliations would have that equal share subdivided by the number of affiliations they had. By

adding up these shares, we observed that the Singapore Eye Research Institute (SERI) had a score of 33.3, having the largest share of affiliated papers in the domain of Ophthalmology in this review. Similarly, the Department of Psychological Medicine, NUS had a score of 19.9, having the largest share of affiliated papers in the domain of Geriatrics in this review. Common to these research groups was their long standing and well-funded cross-sectional and longitudinal surveys such as the Singapore Epidemiology of Eye Disease (SEED) and SLAS.

Funding and main areas of research

We conducted a check on the funding declarations in all the included papers. Of the 368 funded papers, the National Medical Research Council (NMRC) and the Biomedical Research Council (BMRC) funded more than half of them (52% or 191 papers) across all the disciplines. In particular, both Councils were extremely important in funding 97% of the papers on Ophthalmology led by SERI, followed by 76% of the papers on Geriatrics particularly on cognitive impairment led by the Department of Psychological Medicine, NUS and 48% of the papers on Psychiatry especially on depression led by the Department of Psychological Medicine, NUS.

Although NMRC and BMRC's funding cut across all the disciplines, they did not feature prominently in certain disciplines such as Healthcare Services, Built Environment and Oncology. In these disciplines, other types of funding such as from hospitals, Agency for Integrated Care for Healthcare Services, university grants mainly for Built Environment and overseas research grants such as National Cancer Institute (USA) mainly for Oncology were more important.

In-depth review of selected disciplines

Social Category

Caregiving formed the largest subtopic of study (n = 40). More than half of these articles were on the negative effects of caregiving on caregivers (n = 28), with fewer on the positive effects (n = 6). There were 12 articles on employment in this category. More than half of the articles (n = 7) focused on the challenges facing older workers in extending their working lives. An article in this group showed the positive outcomes that are associated with continued employment for older adults.⁽⁷⁾ Despite this, three articles cautioned that simply extending the working lives of seniors may have mixed consequences and even forced them into badly paid jobs that were potentially damaging to their health.⁽⁸⁻¹⁰⁾ There were 10 articles on living arrangements. The majority of these articles (n = 6) examined the negative health-related and social consequences of the elderly living on their own.⁽¹¹⁾ However, while living alone did predict lower psychological well-being, its predictive power decreased when loneliness was taken into account.⁽¹²⁾

Ophthalmology

Most of the articles in this category studied AMD (23% of all the Ophthalmology papers), glaucoma (9%) and cataract (6%). These studies reported findings on associations or risk factors. Similarly, most of the articles on glaucoma and cataract were on their prevalence and risk factors. Interestingly, a number of studies reported associations of eye diseases with cognitive function. For instance, older persons with visual impairment were more likely to have cognitive dysfunction. Such interdisciplinary findings were valuable in understanding the well-being of older persons holistically and ventured beyond compartmentalised disciplines. Most of the data were collected from the SEED, SiMES, SINDI and SCES studies. These

cohort studies enabled in-depth studies on as well as comparison of the three main ethnic groups and international comparisons.

Physical Functioning

There were 72 articles in this category with the following subtopics: injury (n = 32), health status (n = 14), physiological measurements (n = 11), functional ability (n = 10) and exercise (n = 5). Articles on injury covered mainly falls, hip fracture and traumatic brain injury. They were conducted in both community and hospital settings and were generally observational in design. One article provided an interesting multifactorial fall prevention programme in the community. Further such intervention studies would be useful. Articles on health status examined health indicators, quality of life, life expectancy and mortality. Articles on physiological measurements focused on gait speed, hand grip strength and body mass index in relation to health outcomes.

Geriatrics

The category Geriatrics (n = 69) contained three major subtopics: cognition, dementia and frailty. More than two-thirds of the 35 articles on cognition (n = 24) were on the various risk factors for cognitive impairment while 4 articles were on the protective factors against neurocognitive disorders. One innovative paper demonstrated how social factors such as living in a low socio-economic community was independently associated with cognitive impairment. More than half (n = 7) of the 15 articles on dementia were on its prevalence and its behavioural and psychological symptoms. The second major group of the articles (n = 5) were on the risk and protective factors that were associated with having dementia. Half of the 12 articles on frailty were on its prevalence and biomarkers. Most of the articles approached frailty as a physical condition. However, one article pioneered the concept of social frailty as

opposed to physical frailty and established the independent effect of social frailty on the prevalence and incidence of functional disability.⁽¹⁷⁾

Prevention

Almost half of all the 49 articles in this category focused on nutrition (n = 23), followed by health behaviour (n = 11), medication (n = 9) and vaccination (n = 6). Articles on nutrition were mainly cross-sectional and were drawn heavily from the findings of the Singapore Chinese Health Study. Most papers were on dietary patterns and their risk of medical conditions. Articles on health behaviour focused on lifestyle and behaviour, particularly on tobacco use and alcohol drinking. Other topics included seeking and processing of health information and self-care management programmes. Two interesting intervention studies on self-care and the salutogenic programme for older adults were conducted. Such interventional studies are increasingly needed to address the growing prevalence of chronic diseases in the community.

Healthcare Services

More than half of the articles in this category focused on healthcare utilisation (24 out of 46 articles), with the rest on home and long-term care (n = 14), and help-seeking (n = 8). Articles on healthcare utilisation were mostly observational and mainly looked at emergency department visits, hospital admissions and other healthcare utilisation patterns. Articles on home and long-term care were primarily observational in study design, and examined medication usage, rehabilitation, caregiving.

Psychiatry

The common conditions studied under this domain, in decreasing order of frequency, were depression, sleep disorders, psychosis and schizophrenia. Most of the studies were

observational. Studies on depression focused on either quantifying the burden of illness or exploring associated factors. Interestingly, one study expanded the analysis of associated factors from the personal level to area-level measures of socio-economic status. (20) Sleep studies were mostly focused on disturbances in sleep and associated correlates. An interesting theme in this category was the intersection of the health and social dimensions of a condition. For instance, the association of cognitive decline and extreme sleep duration was being moderated by social support. (21)

Cardiology

Studies under this domain were either observational or cost-effectiveness studies. Often, cost-effectiveness studies focused on the effectiveness of different pharmacological drugs as compared to established drugs.

Built Environment

Most of the research in the Built Environment articles (12 out of the total 20 articles) investigated how the attributes of the built environment, such as residential density, can promote physical and cognitive well-being of the elderly.

Oncology

There were few articles categorised under Oncology with topics ranging from general cancer, breast cancer and colorectal cancer. Most of the included studies were observational. While general cancer was studied from a clinical perspective, for example, reporting of common drug-related problems, breast cancer was studied more from an epidemiological perspective. (22,23)

Policy and Planning

Half of the 18 articles in this category were on financing healthcare and the affordability of the healthcare costs. They ranged from financing healthcare costs to general old age financial security, and featured a number of government policy changes. 6 articles studied the economic burden of diseases and projecting future healthcare demand and supply of healthcare professionals.

Endocrinology

Most of the articles in this category looked at diabetes (15 out of 16 articles) and were observational in design. They examined the associations and risk factors for Type 2 diabetes.

DISCUSSION

The medical publications are mostly observational and chiefly examined associations and risk factors for various medical conditions. They were generally discipline-specific and highly specialised. The non-medical publications were also mainly observational but were more interdisciplinary. As shown in this review, there are certain areas of research that can be enriched by considering the social aspects of the ageing process to the medical conditions in question. For instance, the concept of social frailty was demonstrated as an independent variable in explaining the prevalence and incidence of functional disability among older adults.⁽¹⁷⁾ This is in spite of the dominance of the concept of physical frailty in the literature. Indeed, not only is social frailty an important corrective to the dominant interpretation of frailty as simply physical, it also opens up other possible dimensions of frailty that could be further explored.

Another innovative multidisciplinary approach to understanding the medical condition of cognitive impairment can be found in the paper where area-level measures of socio-

economic status of the neighbourhoods were independently associated with cognitive impairment. Hence, there are potentially many areas of medical ageing research that can benefit from the cross-fertilisation of concepts and theories from the non-medical disciplines. This review showed that there were very few interventional studies (only 3% of reviewed publications) across the different disciplines. In view of the challenges ageing presents, there is a need to have more interventional studies and evaluations so that interventions can be validated and scaled up.

From this review, there were common areas of research interest and convergences in the fields of caregiving and dementia. The Program in Health Services and Systems Research, Duke-NUS and the Research Division, Institute of Mental Health (IMH) produced almost half of all papers on caregiving (19 out of 40 papers). The Department of Psychological Medicine, NUS dominated the publications in cognition (21 out of 35 papers or 60%) and frailty (7 out of 12 papers or 58%) but in the field of dementia, it shared almost half the publications (4 out of 10 papers) with the Research Division, IMH (6 papers). There could potentially be more collaboration among these research groups.

Already in the emerging field of frailty, while the Department of Psychological Medicine, NUS led the publications (8 out of 12 papers), both the Department of Geriatric Medicine, NUS and the Research Division, IMH were also active in the field, producing a quarter of the included papers in this review.

This study showed that Singapore had done well in supporting researchers with quality longitudinal surveys such as SLAS, SCHS and WiSE. It was no wonder research groups associated with them produced significant number of publications. To understand the ageing processes better scientifically, the importance of developing rigorous longitudinal databases could not be overemphasised. (24) As mentioned, the NMRC and BNRC funded more than half of the included publications.

Singapore, however, can look to countries like Scotland which linked health and social service data to more accurately identify the relationships between health, social activities and use of resources. (25) In some of these large population studies, sometimes the population was not segmented by age. As Singapore society becomes more diverse, it is important not to see the elderly monolithically. Not only are the elderly segmented by gender and ethnic differences, they are also differentiated by social class and generational differences. A more nuanced understanding of the elderly is needed for future studies.

Internationally, Preventive Health and Successful Ageing have been promoted to enable older persons to have better quality of life and minimise healthcare costs. (24) In this study, there were many studies on Prevention, the fifth discipline with the most number of publications (49 papers with almost half of these papers on nutrition). However, what is needed is for these research findings to be translated into policy and practice. In this study, there were only 8 papers on Healthy Ageing.

There are a number of gaps in the existing research. Some specific groups of vulnerable elderly are understudied. For instance, there was only one paper on older adults with intellectual disability. In a multi-ethnic, multi-religious and multi-lingual society, research on the elderly needs to reflect more strongly how these underlying influences may affect their attitudes and behaviour. Old age well-being includes being having companionship, intimacy and sex. No such studies turned up in this review.

Even in extensively studied topics like caregiving, there are understudied areas as these social phenomena evolve over time. For instance, international initiatives in Gerontechnology, where design and technology can aid independent living and social participation of older persons while minimising the need for caregiving labour, were promoted. (24) In this study, there were only 6 papers on assistive living technology.

This study was not without limitations. One limitation is that the search terms may not have been comprehensive and may have missed out on studies relating to disease conditions. With the large volume of studies reviewed, there is a possibility that key publications may have been excluded. It is also possible that the search terms used such as "older" and "aged" may not be able to capture individuals who are in the young-old category.

Our review was limited to journal publications in English owing to time and resource constraints and we also felt most of the published work on ageing in Singapore were predominantly in English in peer-reviewed journals. This excluded non-journal publications such as books, grey literature and non-English publications which certainly would have added to the breadth and complexity of the review. Another limitation is how the publications are classified by topics. While efforts were made to ensure thematic consistency, there were nevertheless some publications that could be classified under more than one category. However, the number of such papers was relatively small and consensus among the reviewers was used to classify these papers appropriately and avoid double-counting.

The strengths of our review are the following: it was extremely broad and wide-ranging, covering 684 publications in 29 domains of research. It provided a systematic enumeration of the main areas of research that had been done and identified trends and gaps in them. To the best of our knowledge, this is the first scoping review of ageing research in Singapore. We hope this review will provide an empirical basis for researchers and grantor bodies to decide on the areas and direction of studies they should do more research on.

In conclusion, while ageing research had expanded in Singapore in the last decade, it was predominantly discipline-specific and observational in design. As ageing issues are complex, with biology intersecting with psychology and sociology, we call for greater interdisciplinary collaboration, interventional studies and more research in understudied areas and international initiatives on Preventive Health, Successful Ageing and Gerontechnology.




PRISMA flow diagram of the search strategy to identify relevant publications
